SERVICE SPECIFICATIONS

A. Background

The Juvenile Drug Court provides judicial intervention, intensive probation, substance abuse treatment, family therapy, pro-social peer support, and rehabilitation services to juveniles and if needed, their families in a non-confrontational approach using evidencebased practices.

The following provides the specifications for organizations wishing to provide services to the Juvenile Drug Court, Judiciary, State of Hawaii, for the period of October 1, 2013 through September 30, 2014. Upon evaluation and acceptance of proposals, when practicable and upon mutual agreement, contracts may be negotiated, making services available to youth, their peers, adults, and families. The initial contract term will be for the period October 1, 2013 through September 30, 2014.

B. Service Specifications for Juvenile Drug Court

Interested Providers may apply for service specifications as follows:

1. Direct Involvement of Peer Associates of Clients Under the Supervision of the Juvenile Drug Court

The Juvenile Drug Court purchases services in compliance with statutory mandate and orders from the courts. Currently, direct involvement with the peers of the client and the court are non-existent.

Applicant shall provide services to the client's peers within an individual/group setting in their natural environment using redirectional therapy and evidence-based practices (EBP) including but not limited to, cognitive restructuring, social learning approaches, contingency management, and motivational interviewing; promoting a pro-social system with the client's current peer relationship conducive to effective and healthy change; promote and/or support substance abuse treatment using current, evidenced-based methodology.

For the provision of substance abuse treatment services, applicant must adhere to DOH-ADAD's 12-Core Functions. All applicants providing services to the Juvenile Drug Court must have a stable organizational track history comprising of three or more years of relevant service provision and services, which are customized to meet the needs of targeted clients. All applicants must demonstrate knowledge and evidence of Hawaii's Juvenile Drug Court Model; Family Court; criminal background checks; and staff experience, capabilities, and credentials; documentation; and reporting.

Applicants' application will be evaluated in the following areas:

- 1) Experience and Capabilities
- 2) Project Organization and Staffing
- 3) Service Delivery
- 4) Financial
