Based upon the  Ex Parte Motion for Pre-Decree Relief filed by Movant in this action

- own, intend to obtain or possess a firearm and that the firearm may be used to threaten, injure or abuse a person.

ARE ORDERED AS FOLLOWS:

- Do not threaten or physically abuse the Movant or any relatives living with the Movant.
- Do not have any contact with the Movant.
- Immediately leave the residence located at \_\_\_\_\_ and don't go back until this order is changed.
- Do not be within, or pass within, 50 yards of any place where Movant lives. Do not violate this order even if Movant invites you to be at the place where Movant lives.
- Do not have any contact with:

**FIREARMS PROHIBITION**

IT IS ORDERED that you will not possess or control any firearm(s) or ammunition. All permits/licenses are hereby revoked. You must surrender any firearm(s), ammunition, permits and/or licenses that you presently possess or control to any police officer that serves this order. If you are the registered owner of a firearm, you must tell the police officer who serves this order where all such firearms are located. Failure to surrender or to disclose the location of a firearm is a misdemeanor.

If you are able to furnish proof to the police officer serving this order that you are a law enforcement officer, sheriff, member of the armed forces of the State of Hawaii or United States, a mail carrier, or employed by the State of Hawaii or a subdivision thereof, or of the United States and you are required to be armed while on duty, the restrictions do not apply to you to the extent that while you are required to be armed, you may possess or control firearms and ammunition which are official equipment but only while on duty and required to be armed. You shall not possess or control any firearms, ammunition, firearms permits and/or licenses when not on duty nor any personal firearms while on duty.

Failure to comply with this Firearms Prohibition is a violation of HRS Section 134-7(f).
