QUESTIONS AND ANSWERS

1. What is the size of hand towels, bathroom tissue, toilet seat covers and is there a brand that you want to use.

Every site will vary in sizes and types and is up to vendor to accommodate with what is in place presently.

2. What is the size or brand for hand soap dispensers.

Once again vendor needs to accommodate with what is in place at sites being serviced.

3. What size of plastic bags does waste baskets take.

Once again vendor needs to accommodate with what is in place at sites being serviced.

4. For as the recommendation letter do you have to have it? Could you use just the reference. Or do you have to have both?

What is IFB recommendation? It would be left to vendor to enhance bid offer if nothing is recommended in IFB.

5. For the custodial work do you have stay for that length of time which is stated in the contract?

Yes. Vendor is there to fulfill contracted hours per visit.

6. Is the current contractor paying state wages?

Yes.

7. Also do you have pay state wages which the contract states?

The current wages paid for Janitor II is \$18.72 per hour.
